Cancellation, Deferral, Intermision and Transfer

Cancellation, Deferral, Intermision and Transfer (as each of those terms is defined in the Terms and Conditions) requests carry the same fee liability consequences as Cancellation as they all involve the Cancellation of a reserved course place.

Your fee liability on Cancellation, Deferral, Intermision and Transfer is based on the Tuition Fee as set out in the table below, regardless of the instalment plan you have chosen.

Cooling off period

- Students can cancel their courses within 14 days of acceptance (the "cooling off period").

- If you cancel during the cooling off period and before your Course start date, you will not be liable for your Annual Tuition Fee.

- If you cancel during the cooling off period but your course has already started, The University of Law can charge for materials provided and a reasonable pro-rata fee.
