

Terms and Conditions for The University of Law Alumni Discounts

These terms and conditions (these "Terms") apply only to students of The University of Law Limited (Company No.07933838 whose registered office is at 2 Bunhill Row, London EC1Y 8HQ (the "University" or "we", "us" or "our") who meet the Eligibility Criteria (set out in paragraph 2 below) for one of the Alumni Discounts that the University offers (as detailed in paragraph 1 below) and who have applied for a place on a Second Course (defined below) that is due to start between 1 July 2024 and 30 June 2025.

Please note that these Terms apply in addition to our general terms and conditions that apply to courses delivered by the University and that are provided to you when you receive your offer of a place on a course by the University ("Student Terms and Conditions").

1. The Alumni Discounts

- 1.1 There are five available discounts for Alumni of the University (each an "Alumni Discount" and together called the "Alumni Discounts"). In order to receive an Alumni Discount you must meet all eligibility criteria outlined in paragraph 2 of these Terms in addition to any specific criteria for each Alumni Discount. The Alumni Discounts are:
 - 1.1.1 **The Early Bird Alumni Discount.** If your Second Course is not a course listed in paragraph 1 of the Schedule of Relevant Second Courses and you accept a place on your Second Course over 6 months prior to the course start date, the University will apply an additional discount of £250.
 - 1.1.2 The General Alumni Discount. If your second course is not a course listed in paragraph 2 of the Schedule of Relevant Second Courses then the University will reduce your Second Course Tuition Fee (as defined below) by £500; or
 - 1.1.3 *The Academic Masters Alumni Discount*. If your Second Course <u>is</u> one of the courses listed in paragraph 3 of the Schedule of Relevant Second Courses, then the University will reduce your Second Course Tuition Fee (as defined below) by £1000; and
 - 1.1.4 The SQE Preparation Course Alumni Discount. If your second course <u>is</u> listed in paragraph 4 of the Schedule of Relevant Second Courses then the University will reduce your Second Course Tuition Fee by £250; or
 - 1.1.5 *US Bar Preparation Course Alumni Discount.* If your second course <u>is</u> listed in paragraph 5 of the Schedule of Relevant Second Courses then the University will reduce your Second Course Tuition Fee by £250.

1.2 For the purposes of these Terms:

- 1.2.1 "Second Course" means a second course undertaken with the University;
- 1.2.2 "Fee Schedule" means the fee schedule relating to your course and your Second Course as

- provided to you by the University when you received your offer for your Course or Second Course; and
- 1.2.3 **"Second Course Tuition Fee"** means the course fees applicable to your Second Course as described in the Student Terms and Conditions and the Fee Schedule.
- 1.2.4 "Schedule of Relevant Second Courses" means the schedule to these Terms which lists the courses relevant to whether you qualify for a particular Alumni Discount contained in Schedule 1 to these Terms.
- 1.2.5 "Sponsored Student" means a student whose Second Course Tuition Fee is paid in full through a bursary, scholarship or financial sponsorship whether from the University, an employer, or any other person, institution or business (a "Sponsoring Party").
- 1.3 The Alumni Discounts apply to discount your fees on your Second Course only.

2. Eligibility Criteria

- 2.1 To be eligible to receive one of the Alumni Discounts on offer you must meet all of the following eligibility criteria (the "Eligibility Criteria"):
 - 2.1.1 You must have completed or be currently be studying one of the following courses, delivered solely by the University (a "Course"):
 - Level 3 Foundation Certificate
 - BA (Hons)- Bachelors of Arts
 - BSc (Hons)- Bachelors of Science
 - LLB (Hons)
 - Graduate Diploma in Law
 - Postgraduate Diploma
 - Legal Practice Course
 - BPTC / Bar Practice Course
 - LLM- Master of Laws
 - MA- Masters of Arts
 - MSc- Masters of Sciences
 - SQE Law Essentials
 - SQE1 Preparation Course (eligible for the SQE Preparation Course Alumni Discount only)
 - 2.1.2 You must have received an offer for, or booked with the University, a place on a Second Course;
 - 2.1.3 In accordance with clauses 1.1.1. to 1.1.5 inclusive, to be considered for an Alumni Discount, your Second Course must be either be a course listed or excluded from the relevant section in the Schedule of Relevant Second Courses to these Terms;
 - 2.1.4 Where applicable, you must pay your Second Course Tuition Fee in accordance with the relevant Fee Schedule;
 - 2.1.5 You must meet the University's admissions criteria for your Second Course as set out on the University's website;
 - 2.1.6 You must not be a Sponsored Student (or become sponsored prior to the first day of your Second Course) by a Sponsoring Party; and
 - 2.1.7 You must comply with these Terms and the Student Terms and Conditions at all times during both your Course and your Second Course.

- 2.2 You will not be eligible for or will cease to be eligible for the Alumni Discounts if any of the following apply:
 - 2.2.1 You do not successfully graduate from your first Course with the University;
 - 2.2.2 You fail to meet the entry and eligibility requirements for the Second Course as stated on the University's website;
 - 2.2.3 You are withdrawn or excluded from your Second Course by the University (see paragraph 4.4 below);
 - 2.2.4 You cancel your place on your Second Course;
 - 2.2.5 You transfer onto a course that does not qualify for an Alumni Discount of an equivalent or higher value in accordance with the relevant section of the Schedule of Relevant Second Courses;
 - 2.2.6 You are or become a Sponsored Student (as defined in paragraph 2.1.6);
 - 2.2.7 You are or become an employee of the University or a family member of an employee or an agent of the University or any of its associated, affiliated or subsidiary companies and, as a result, are able to access the employee benefits of a discounted course fee for any University course; and;
 - 2.2.8 In relation to the Early Bird Alumni Discount, where you accept your place for your Second Course less than 6 months prior to the course start date.
- 2.3 If you defer or intermit your place on your Second Course once and for one academic year, you will continue to be eligible for the Alumni Discounts. For further details on your right to defer, please refer to your Student Terms and Conditions.
- 2.4 If at any time you cease to meet the Eligibility Criteria for the Alumni Discounts as set out in these Terms: you may be liable to pay to the University the full amount of your Second Course Tuition Fee as set out in your Fee Schedule without the Alumni Discount being applied. Please refer to the Student Terms and Conditions for further details of your responsibilities and obligations in relation to the payment of fees.

3. Application of the Alumni Discount

- 3.1 If you meet the Eligibility Criteria, the applicable Alumni Discount will be allocated automatically to you once you have accepted your offer from the University to study a Second Course. The University will automatically:
 - 3.1.1 in relation to the General Alumni Discount:
 - (a) reduce your deposit for your Second Course by £250; and
 - (b) apply a reduction of £250 to your final instalment of the balance of your Second Course Tuition Fee (according to your Fee Schedule, instalment or payment plan);
 - 3.1.2 in relation to the Early Bird Alumni Discount, SQE Preparation Course Alumni Discount, US Bar Preparation Course Alumni Discount:
 - (a) apply a reduction of £250 to the final instalment of the balance of your Second Course Tuition Fee (according to your Fee Schedule, instalment or payment plan);
 - 3.1.3 in relation to the Academic Masters Alumni Discount:
 - (a) reduce your deposit for your Second Course by £250; and
 - (b) apply the remaining £750 to the final instalment(s) of the balance of your Second Course Tuition Fee (according to your Fee Schedule, instalment or payment plan).

4. General

- 4.1 The University may offer a number of promotional offers, offers of reimbursement, scholarships, awards, bursaries, discounts or credits (each an "Award") from time to time. The University allows students to receive some Alumni Discounts, other than the Academic Masters Alumni Discount, in conjunction with certain other Awards and other Alumni Discounts, as set out in more detail below.
- 4.2 Students may receive the Early Bird Alumni Discount in conjunction with the General Alumni Discount (subject to meeting the applicable eligibility criteria) but no other combination of Alumni Discounts is permitted.
- 4.3 Students who have been awarded the Early Bird Alumni Discount together with the General Alumni Discount may also receive any number of other Awards (subject to meeting the applicable eligibility criteria) unless it is listed in Schedule 2 to these Terms (the "Excluded Awards").
- 4.4 Students who have been awarded the Academic Masters Alumni Discount will not be able to receive any other Alumni Discount or Award.
- 4.5 The Alumni Discounts are awarded at the sole discretion of the University and the University's decision shall be final.
- 4.6 The University reserves the right to withdraw Alumni Discounts at any time prior to the commencement of the relevant Second Courses in any academic year.
- 4.7 The University reserves the right, with reasonable cause, to withdraw your place on or exclude you from a Second Course or withhold or withdraw the Alumni Discount if you violate any of these Terms and/or any other applicable University policies or terms and conditions including the Student Terms and Conditions. The University policies are available on the University's website at https://www.law.ac.uk/policies/
- 4.8 These Terms apply in addition to (and do not replace) our Student Terms and Conditions in relation to your Second Course. Please refer to our Student Terms and Conditions for other terms that apply to your Second Course. If there are any conflicts or discrepancies between these Terms and our Student Terms and Conditions, the Student Terms and Conditions will prevail.
- 4.9 You must notify the University immediately of any change in your circumstances that may affect your eligibility to receive the Alumni Discount. If you fail to do so, the University will be entitled to recover or adjust (as appropriate) any award given or to be given to you under the Alumni Discount. The University shall also be entitled to recover or adjust any Alumni Discount given in error.
- 4.10 The University may make amendments to these Terms at any time. Any amendments will be published on the University's website and notification given to you of any such changes that affect you.
- 4.11The University may be responsible to you for foreseeable loss and damage caused by the University. If we fail to comply with these Terms, we are responsible for loss or damage you suffer that is a foreseeable result of our breaking these Terms or our failing to use reasonable care and skill, but we are not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time the contract was made, both we and you knew it might happen, for example, if you discussed it with us

- during the application process.
- 4.12 We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors; for fraud or fraudulent misrepresentation.
- 4.13 Even if the University delays in enforcing these Terms, the University can still enforce them later. If the University does not insist immediately that you do anything you are required to do under these Terms, or if the University delays in taking steps against you if you break these Terms, it will not mean that you do not have to do those things or prevent the University from taking steps against you at a later date.
- 4.14 These Terms are governed by English law and where necessary you can bring legal proceedings in connection with them in the English courts.
