

The University of Law Limited Hong Kong Campus Award

Terms and Conditions for Courses delivered in or into the University of Law Hong Kong Campus Effective from 3 May 2024

Please note that these terms and conditions (these “**Terms**”) apply only to the HK Courses (as defined below) designed and delivered by The University of Law Limited (No.07933838) (“**the University**”) in or into Hong Kong, in each case commencing on a date between 1 July 2024 and 30 June 2025 at the University of Law Hong Kong Campus.

The Hong Kong Campus Award

1. For the purposes of these Terms:

(a) “**Fee**” means the total published tuition fee to be paid to the University for your HK Course (as defined below) and any fees, costs or expenses which are not tuition fees are expressly excluded. For the avoidance of doubt, the following items are outside the scope of the Fee (without limitation): costs relating to accommodation, living, food, subsistence, travel, stationery, computer or computer equipment, registration, enrolment; fees charged either by the provider, any of its partners and/or any other governing or regulatory body in connection with your studies; library charges; printing charges; and costs associated with retaking any assessment;

(b) “**Fee Reduction**” means the amount by which your Fee will be reduced pursuant to the Hong Kong Award as per paragraph 5 of these Terms;

(c) “**Fee Schedule**” means the schedule of charges setting out the applicable Fee for your specific HK Course which forms part of the Main HK Terms (as defined below) and which is sent to you upon confirmation of your acceptance of a Course place with the University;

(d) “**Fee Liability**” means the amount that you are obliged to pay for your HK Course (if any) once your acceptance of your HK Course place has been confirmed by the University;

(e) the “**General Alumni Discount**” means the Alumni scheme offered to individuals who have successfully completed (or are due to complete) one of the University’s courses, a discount of HKD\$5,000 against their next fee, further details of which can be found here <https://www.law.ac.uk/alumni/loyalty/>;

(f) “**HK Course**” or “**HK Courses**” means **all** courses or courses run in or (for online delivery) to the ULaw HK Campus (as defined below), but **excluding** the following:

- i. PCLL Conversion Examinations Preparatory Course (PPC) – On Campus and Online
- ii. SQE Law Essentials - Online
- iii. SQE1 Preparation Course - On Campus and Online
- iv. SQE1 Preparation for Legal Professionals - Online
- v. SQE2 Preparation Course - On Campus and Online
- vi. SQE2 Preparation for Legal Professionals - Online
- vii. SQE1 Exam Preparation Course - On Campus and Online
- viii. SQE2 Exam Preparation Course - On Campus and Online
- ix. U.S. Bar Preparation Course – Online

(g) the “**Hong Kong Award**” means The University of Law Limited Hong Kong Campus Award;

(h) “**Main HK Terms**” means the terms and conditions for your HK Course which are sent to you upon confirmation of your acceptance of a HK Course place with the University available at <https://www.law.ac.uk/student-terms-and-conditions/>;

(i) “**Student**” means an individual who has been offered, accepted and been sent confirmation of their acceptance of a HK Course place with the University; and

(j) “**ULaw HK Campus**” means the University of Law campus in Hong Kong at which the HK Courses are offered.

Eligibility

2. To be considered eligible for the Hong Kong Award you must meet the following criteria (the “**Eligibility Criteria**”):

- (a) You meet the University’s admissions criteria for your chosen HK Course as set out on its website from time to time.
- (b) You have been offered, accepted and been sent confirmation of your acceptance of a HK Course place with the University.
- (c) Your HK Course is scheduled to be studied on the ULaw HK Campus between 1 July 2024 to 30 June 2025.
- (d) You may not accept any other discount, bursary or scholarship (each an “**Award**”) to begin and/or complete your HK Course other than the Hong Kong Early Bird Discount (further information may be found at <https://www.law.ac.uk/locations/hong-kong/>). If you are eligible for the Hong Kong Early Bird Discount, the Fee Reduction for both the Hong Kong Award and the Hong Kong Early Bird Discount will be applied to your HK Course Fee at the same time.
- (e) Please note that Alumni Awards are not available in conjunction with the Hong Kong Award, further information about Alumni Awards may be found at <https://www.law.ac.uk/about/alumni/loyalty-scheme/>.
- (f) You have not accepted a place to study a similar or comparable course to your HK Course with another course provider.
- (g) You have not applied for or been granted any academic exemptions or recognition of prior learning by the University.

2. Please note that even if you meet the Eligibility Criteria in paragraph 2, you will not be eligible for or will cease to be eligible for the Hong Kong Award if any of the following apply:

- (a) You cancel your place on your HK Course (see paragraph 11 below).
- (b) You are withdrawn from your HK Course (see paragraph 11 below).
- (c) You transfer your place on your HK Course to another course which is not a HK Course (see paragraph 10 below).
- (d) You defer your place on your HK Course (see paragraph 10 below).
- (e) You intermit your place on your HK Course (see paragraph 10 below).
- (f) You are a sponsored student (or become sponsored prior to the first day of your HK Course).
- (g) You have secured or subsequently obtain, full financial sponsorship for your HK Course from your employer or other sponsoring organisation.
- (h) You are or become an employee or a family member of an employee or an agent of the University or any of its associated, affiliated or subsidiary companies.
- (i) Any part of your application for your HK Course place or any information subsequently provided to the University in connection with the Hong Kong Award (including, without limitation, any financial information) is misrepresentative or fraudulent.

4. If you become ineligible under paragraph 3 of these Terms at any time during your HK Course, you will become immediately liable for the full Fee Liability for your HK Course, as set out in the Main HK Terms.

Maximum Fee Reduction

5. Any Fee Reduction awarded to you pursuant to these Terms will be a HKD\$5,000 reduction of the HK Course Fee per student (which is in addition to the Hong Kong Early Bird Discount you may be eligible for as per paragraph 2(d) of these Terms). The University reserves the right to increase or decrease this amount at any time.

Application of the Hong Kong Award

6. The Hong Kong Award will be allocated to you automatically once you are in receipt of an offer from the University and will then be applied once you have accepted that offer to study at the University.

7. Any deposit payable for your HK Course will not be subject to the Hong Kong Award and the Fee Reduction shall only apply to your HK Course Fee.

8. Your Fee Reduction will be credited directly to your University account once you have been offered, accepted and been sent confirmation of your acceptance of a HK Course place with the University and paid

any applicable deposit. The Fee Reduction will be applied to your final HK Course fee instalment(s) to reduce your fee payment(s) by the same amount.

9. Once you have accepted the University's offer you will be issued with a new Fee Schedule to illustrate your new Fee Liability for both instalment and lump sum payment options.

Deferral, Transfer and Intermission

10. The Hong Kong Award is not transferrable. Therefore, if you defer or intermit from your HK Course to another course or campus or if you transfer your place on your HK Course to another course which is not a HK Course, your Fee Reduction cannot be transferred. In these circumstances, any Fee Reduction awarded under the Hong Kong Award will be allocated proportionally across your total Fee Liability. You will retain any proportional allocation for Fee liability which has passed, but will lose any amount allocated to future Fee Liability. This amount will be confirmed by the University's Student Finance team by way of email. Your Fee Liability can be found within the Fee Schedule for your HK Course.

11. In the event that you are awarded the Hong Kong Award and then cancel your place on your HK Course or are withdrawn by the University after the No Fee Liability deadline set out in the Fee Schedule for your HK Course, you will forfeit your Fee Reduction and be personally liable for the Full Fee Liability in accordance with the Main HK Terms.

12. Except as stated at paragraph 2(e) of these Terms the Hong Kong Award is not to be combined with any other offer of reimbursement, rebate or credit offered by the University for any HK Course or any other courses offered by it.

13. The Hong Kong Award is awarded at the sole discretion of the University and the University's decision shall be final.

14. The University reserves the right to withdraw the Hong Kong Award at any time.

15. You may not transfer any of your rights under these Terms to any other person (including a company or business).

16. If there is a delay in the University carrying out its obligations to you under these Terms caused by circumstances beyond the reasonable control of the University, then the University shall not be liable to you (or any other person) for the consequences of that delay.

17. If there is a conflict between these Terms, the Main HK Terms or any other terms and conditions issued by the University relevant to the Hong Kong Award, then these Terms shall prevail. For the avoidance of doubt, if your Hong Kong Award is revoked, your Fee Liability will be the full Fee Liability for your chosen HK Course as set out in the Main HK Terms and the Fee Schedule for your chosen HK Course.

18. These Terms are governed by English law and both the University and you irrevocably submit to the exclusive jurisdiction of the English courts for any claim arising under or in connection with these Terms and any non-contractual obligation arising out of or in connection with them.
