

The University of Law Limited Hong Kong Early Bird Discount

Terms and Conditions for Courses delivered in or into Hong Kong Effective from 3 May 2024

Please note that these terms and conditions (these “**HK Terms**”) apply only to the HK Courses (as defined below) designed and delivered by The University of Law Limited (No.07933838), (“**the University**”), in or, (for online delivery) into Hong Kong and in each case commencing on a date between 1 July 2024 and 30 June 2025 at the University Hong Kong Campus.

The Promotion

1. The University of Law Limited Hong Kong Early Bird Discount (the “**Promotion**”) will run from 1 July 2024 to 30 June 2025 inclusive. If you meet the Eligibility Criteria (as defined in paragraph 4 of these Terms) the University will reduce your Fee (as defined below) by HKD\$10,000 applied as set out in paragraph 7 of these Terms (the “**Fee Reduction**”).
2. For the purposes of these HK Terms:
 - (a) “**Fee**” means the total published tuition fee to be paid to the University for your HK Course prior to the application of any discounts, bursaries or promotional awards. Any fees, costs or expenses which are not tuition fees are expressly excluded. For the avoidance of doubt, the following items are outside the scope of the Fee (without limitation): costs relating to accommodation, living, food, subsistence, travel, stationery, computer or computer equipment, registration, enrolment; fees charged either by the provider, any of its partners and/or any other governing or regulatory body in connection with your studies; library charges; printing charges; and costs associated with retaking any assessment;
 - (b) “**Fee Schedule**” means the schedule of charges setting out the applicable Fee for your specific HK Course (as defined below) which forms part of the Main HK Terms (defined below) and which is sent to you upon the offer and acceptance of your place on your HK Course;
 - (c) “**Fee Liability**” means the amount that you are obliged to pay for your HK Course (if any) once your acceptance of your HK Course place has been confirmed by the University;
 - (d) “**First Instalment Payment**” means the receipt by the University in cleared funds of the amount required to satisfy the first instalment of the Fees as stated on your Fee Schedule;
 - (e) “**HK Course**” or “**HK Courses**” means **all** courses or courses run in or (for online delivery) to the University Hong Kong Campus, but **excluding** the following:
 - i. PCLL Conversion Examinations Preparatory Course (PPC) – On Campus and Online
 - ii. SQE Law Essentials - Online
 - iii. SQE1 Preparation Course – On Campus and Online
 - iv. SQE1 Preparation Course - On Campus and Online
 - v. SQE1 Preparation for Legal Professionals – Online
 - vi. SQE2 Preparation Course – On Campus and Online
 - vii. SQE2 Preparation for Legal Professionals - Online
 - viii. SQE1 Exam Preparation Course - On Campus and Online
 - ix. SQE2 Exam Preparation Course - On Campus and Online
 - x. U.S. Bar Preparation Course – Online

If you are commencing an SQE Course please refer to the SQE Incentives Terms and Conditions for information relating to any applicable discounts.

- (f) **“Main HK Terms”** the terms and conditions for your HK Course which are sent to you upon the offer and acceptance of your place on your HK Course available at <https://www.law.ac.uk/student-terms-and-conditions/>;
- (g) **“Reduced Fee Schedule”** means a Fee Schedule which incorporates the Fee Reduction;
- (h) **“Sponsored Student”** means a Student who is sponsored via a third party (e.g. their government, or employing or commercial organisation etc); and
- (i) **“Student”** means an individual who has been offered, accepted and been sent confirmation of their acceptance of a HK Course place with the University.

Eligibility

3. To be considered for the Promotion, you must meet the following eligibility criteria (the **“Eligibility Criteria”**):
 - (a) You meet the University’s admissions criteria for your chosen HK Course as set out on its website from time to time.
 - (b) You have been offered, accepted and been sent confirmation of your acceptance of a HK Course place with the University prior to the date relevant to your intake/ course start date below:
 - i. September 2024 intake deadlines for you to accept your place on your HK Course are as set out below.

Deadline: 12 August 2024 for the following HK Courses:

 - Postgraduate Diploma (Law Conversion) PgDL- On Campus and Online
 - MA Law (Conversion) - On Campus and Online
 - MA Law (SQE1) - On Campus and Online
 - LLB (Hons) Law - Online

Deadline: 26 August 2024 for the following HK Courses:

 - LLM courses - On Campus and Online
 - ii. January 2025 intake deadlines for you to accept your place on your HK Course are as follows:

Deadline: 9 December 2024 for the following HK Courses:

 - Postgraduate Diploma (Law Conversion) PgDL - On Campus and Online
 - MA Law (Conversion) - On Campus and Online
 - MA Law (SQE1) - On Campus and Online

Deadline: 16 December 2024 for the following HK Courses:

 - LLB(Hons) Law - Online

Deadline: 30 December 2024 for the following HK Courses:

 - LLM Courses - On Campus and Online
 - (c) You are not a Sponsored Student and do not become a Sponsored Student prior to the first day of your HK Course.
 - (d) You have not accepted a place to study a similar or comparable course to your HK Course with another course provider.
 - (e) You have selected Hong Kong as your home campus.
 - (f) You have not applied for or been granted any academic exemptions or recognition of prior learning by the University.
4. If you meet the Eligibility Criteria, you will still not be eligible for or cease to be eligible for the Promotion if any of the following apply:
 - (a) You cancel your place on your HK Course;
 - (b) You are withdrawn from your HK Course;
 - (c) You Transfer (as defined in the Main HK Terms) your place on your HK Course to a course

which is not a HK Course;

- (d) You Intermit (as defined in the Main HK Terms) your place on your HK Course;
 - (e) You Defer (as defined in the Main HK Terms) your place on your HK Course;
 - (f) You become a Sponsored Student prior to the first day of your HK Course;
 - (g) You are or become an employee or a family member of an employee or an agent of the University or any of its associated, affiliated or subsidiary companies; or
 - (h) Any part of your application for your HK Course place or any information subsequently provided to the University in connection with your application or the Promotion (including, without limitation, any financial information) is misrepresentative or fraudulent.
5. If you become ineligible under these HK Terms at any time during your HK Course, you will become immediately liable for the full Fee Liability for your HK Course, as set out in the Main HK Terms.

Application of Fee Reduction

6. The Fee Reduction will be allocated to you if you accept the University's offer prior to the date relevant to your intake as set out in paragraph 4(b). The Fee Reduction will be applied to your University account after you have accepted your place with the University and been sent confirmation of your acceptance of a HK Course place with the University. The Fee Reduction will be applied to your final instalment(s) to reduce your Fee Liability by the same amount (where relevant). You will then be issued with a new Reduced Fee Schedule to illustrate your new Fee Liability. This Reduced Fee Schedule will incorporate the Fee Reduction.
7. Any Fee Reduction awarded to you pursuant to the Promotion will be limited to HKD\$10,000.
8. Any Fee Reduction you are awarded will be in addition to any other Award you may be eligible for, (as defined in paragraph 10 of these Terms). The University reserves the right to increase or decrease this amount at any time.
9. Should your HK Course require you to pay a deposit, this deposit will not be subject to the Fee Reduction.
10. You may not accept any other discount, bursary or scholarship (each an "Award") to begin and/or complete your HK Course other than the Hong Kong Award (further information may be found at <https://www.law.ac.uk/locations/hong-kong/>). The Fee Reduction for the Promotion and the Hong Kong Award will be applied to your HK Course Fee at the same time.

Cancellation, Deferral, Transfer and Intermission

12. In the event that you are awarded a Fee Reduction and you then cancel your place on your HK Course or are withdrawn by the University after the No Fee Liability deadline set out in the Fee Schedule for your HK Course (which, for the avoidance of doubt, will be the same deadline as set out in the Reduced Fee Schedule), you will forfeit your Fee Reduction and be personally liable for the Full Fee Liability in accordance with the Main HK Terms.
13. Subject to paragraph 14 of these Terms, the Fee Reduction is not transferrable. Therefore, if you Defer, Intermit or Transfer (each as defined in the Main HK Terms) from your HK Course to another course, your Fee Reduction cannot be transferred. In these circumstances, you will retain any proportional allocation for Fee liability which has passed, but you will lose any amount allocated to future Fee Liability. This amount will be confirmed by the University's Student Finance team by way of email. Your Fee Liability can be found within the Fee Schedule for your HK Course.
14. In the event that you Transfer (as defined in the Main HK Terms) from your HK Course to another HK Course, your Fee Reduction will be transferred. Your new Fee Liability will be confirmed by the University's Student Finance team by way of email.

15. Except as stated in paragraph 9 of these Terms the Promotion is not to be combined with any other offer of reimbursement, rebate or credit offered by the University for any HK Course or any other courses offered by it.
16. All Fee Reductions are awarded at the sole discretion of the University and the University's decision shall be final.
17. The University reserves the right to withdraw this Promotion at any time.
18. You may not transfer any of your rights under these HK Terms to any other person (including a company or business).
19. If there is a delay in the University carrying out its obligations to you under these HK Terms caused by circumstances beyond the reasonable control of the University, then the University shall not be liable to you (or any other person) for the consequences of that delay.
20. If there is a conflict between these HK Terms and the Main HK Terms or any other terms issued by the University relevant to the Promotion, then these HK Terms shall prevail. For the avoidance of doubt, if your Fee Reduction is revoked, your Fee Liability will be the full Fee Liability for your chosen HK Course as set out in the Main HK Terms and the Fee Schedule for your chosen HK Course.
21. These HK Terms are governed by English law and both the University and you irrevocably submit to the exclusive jurisdiction of the English courts for any claim arising under or in connection with these HK Terms and any non-contractual obligation arising out of or in connection with them.
