

Terms and Conditions for The University of Law International Early Bird Discount Scheme

Effective from 05.06.24

These terms and conditions apply to the University of Law's international early bird discount scheme. The scheme offers an early bird discount on course fees to eligible International Students who receive an offer on a Qualifying Course (each as defined below) with The University of Law Limited (No.07933838) ("**ULaw**", "**we**" "**our**" or "**us**") and who accept this offer and pay a course deposit before the specified date for their intake ("**International Early Bird Discount**").

You should pay particular attention to the provisions of clauses 3.4, 4.3, 4.4, 7, 9, 12.5 and 12.7.

For the avoidance of doubt, you remain bound by these Terms in addition to the Student Terms and Conditions (as defined below). Please note that if you accept your place on a Qualifying Course (defined below) at ULaw but cease to be eligible for the International Early Bird Discount, **you may be liable to pay the full course fees (without a discount) in accordance with the Student Terms and Conditions and Fee Schedule.**

1. Glossary

We use definitions (indicated by capital letters) in these Terms which have the meanings set out in this clause 1. Note some definitions from the Student Terms and Conditions may also be used in these Terms – we have indicated where this applies.

- a. "**Annual Tuition Fees**" means the sum to be paid by way of tuition fees for your Qualifying Course which will be as set out in your Fee Schedule. Please note that 'Fees' do not include your accommodation or living costs (including for food, travel, stationery, computer equipment, registration or enrollment fees), reassessment or resit costs (if any), library or printing charges, or any other charges made either by ULaw (or its partners) or any other governing or regulatory body in connection with your studies in the United Kingdom ("**UK**");
- b. "**Eligibility Criteria**" means the requirements you must meet to be considered eligible for the International Early Bird Discount and which are set out in clause 3 of these Terms;

- c. **“Fee Schedule”** means the schedule setting out the Annual Tuition Fees that you are required to pay for the Qualifying Courses offered by ULaw and which is sent to you in an email when ULaw offers you a place on the Qualifying Course and again when you accept your place on your Qualifying Course.
- d. **“International Student”** means a student who has a confirmed place on a Qualifying Course, whose nationality is not British, and who does not have a ‘settled’ or ‘pre-settled’ status and is an overseas/international fee payer. International Students must provide Satisfactory Evidence (defined below) to demonstrate that they qualify as an International Student.
- e. **“Qualifying Course”** means those face to face, attendance mode courses offered by ULaw at a UK campus in clause 2 which qualify for the International Early Bird Discount;
- f. **“Satisfactory Evidence”** means evidence required to demonstrate you qualify as an International Student as detailed in clause 4.1 below; and
- g. **“Student Terms and Conditions”** means the financial and contractual obligations set out in ULaw’s terms and conditions applicable to your enrolment on a Qualifying Course with ULaw, including the applicable Fee Schedule, which are available on the website at www.law.ac.uk and which were provided to you by ULaw with the letter offering you a place on a Qualifying Course;
- h. **“Terms”** means these terms and conditions which apply to the International Early Bird Discount.

2. Qualifying Courses

2.1. The International Early Bird Discount applies to all courses **except** the following:

- (a.) any course studied online;
- (b.) SQE courses (including SQE 1 Preparation for Legal Professionals, SQE 1 and 2 Preparation courses, SQE 1 and 2 Exam Preparation courses, SQE Law Essentials)
- (c.) Pre-Sessional English course;
- (d.) the US Bar Preparation course; or
- (e.) any other course which has a duration of less than 6 months.

3. What are the Eligibility Criteria for the International Early Bird Discount?

3.1. To be eligible for the International Early Bird Discount you must:

- (a.) be an individual who meets ULaw’s admissions criteria (which may be updated from time to time) as set out on the ULaw’s website; and
- (b.) accepted a place on a Qualifying Course at one of ULaw’s UK campuses; and
- (c.) require a Student Route Visa for your Qualifying Course and have paid the

required £6000 payment towards your Annual Tuition Fees (this payment will either be required at the point you accept your offer referred to as the 'International Acceptance Payment' in your Student Terms and Conditions or later in connection with your Student Route Visa application process as set out in your Student Terms and Conditions) by no later than the relevant following date:

and

- (d.) be classified as an International Student (as defined in the [Glossary](#)); and
- (e.) be able to provide Satisfactory Evidence (as defined in the [Glossary](#)) to show that you classify as an International Student; and
- (f.) be required to have accepted a place on a Qualifying Course on a Student Route visa. For further information about Student Route visas please refer to the webpage [UK Visa Requirements | University of Law](#).

3.2. You must notify ULaw immediately of any change in your circumstances which may affect your eligibility to receive the International Early Bird Discount. If you fail to do so, ULaw will be entitled to recover from you the value of the discount given to you under the International Early Bird Discount.

3.3. You will cease to be eligible for the International Early Bird Discount if at any time you:

- (a.) you transfer to a course that is not a Qualifying Course (please see clause 2);
- (b.) secure or subsequently obtain, full financial sponsorship for your course from an employer or other sponsoring organisation; or
- (c.) you receive a loan or grant from The Student Loans Company UK (please see The Student Loans Company [website](#) for further information).

3.4. If you become ineligible to receive the International Early Bird Discount under clause 3.3 at any time during your Qualifying Course, you will be liable for the Annual Tuition Fees for your Qualifying Course without any discount or Award (as defined in clause 8) applied, in accordance with your Student Terms and Conditions and your Fee Schedule.

4. Satisfactory Evidence required to qualify for the International Early Bird Discount

- 4.1. For the purposes of clause 3.1(d.) to qualify for the International Early Bird Discount, Satisfactory Evidence means originals or copies of passports, evidence submitted on CAS Shield and/or your application to receive a Confirmation of Acceptance of Studies (“**CAS**”) from ULaw, and any other proof for the nationality that you stated on your application to study at ULaw (“**Satisfactory Evidence**”).
- 4.2. Please note ULaw will take copies of original Satisfactory Evidence documents at your enrolment on campus before you commence your Qualifying Course.
- 4.3. Failure to provide accurate and complete Satisfactory Evidence will mean that you immediately cease to be eligible for the International Early Bird Discount and the provisions of clause 3.4 (above) will apply.
- 4.4. The ULaw reserves the right to request you to submit any further evidence as it may reasonably require to ascertain your eligibility for the International Early Bird Discount. You will be given a period of time within which you must respond to that request. Failure to respond within the given timeframe will mean that you immediately cease to be eligible for the International Early Bird Discount and the provisions of clause 3.4 (above) will apply.

5. Amount of the International Early Bird Discount

- 5.1. The value of the International Early Bird Discount is **£500** for the following intakes: July 2024 to October 2024, January 2025 to March 2025, May 2025 to June 2025.

6. Application of the Early Bird Discount

- 6.1. You do not need to make an application for the International Early Bird Discount. So long as you meet the Eligibility Criteria, the International Early Bird Discount will automatically be applied to your ULaw account and will reduce the remainder of the Annual Tuition Fees payable.

7. Limitations on the International Early Bird Discount

- 7.1. ULaw reserves the right to withdraw the International Early Bird Discount at any time and does not guarantee that the International Early Bird Discount will always be available. ULaw will notify students in advance if at any time it decides to withdraw the International Early Bird Discount.

8. How does the Early Bird Discount relate to other Awards, Discounts, Scholarships and Bursaries?

- 8.1 You will be entitled to receive the International Early Bird Discount and any other award, discount, credit, rebate, scholarship or bursary offered by ULaw (each an “**Award**”) unless it is listed in Schedule 1 to these Terms (the “**Excluded Awards**”).
- 8.2 You may receive the International Early Bird Discount alongside one Alumni Discount

(excluding those listed as Excluded Awards in Schedule 1), and one other additional Award subject to availability and subject to you meeting the eligibility criteria for that Award.

9. What happens if you receive the International Early Bird Discount but decide to cancel/withdraw your place on a Qualifying Course?

Please read this clause alongside your Student Terms and Conditions.

- 9.1. In the event that you cancel your place on your Qualifying Course after the “**Cooling Off Period**”, (defined in your Student Terms and Conditions), depending on the date on which you cancel, you may still be liable to pay all or part of your Annual Tuition Fees as set out in your Fee Schedule.
- 9.2. If, at the date you cancel your place on your Qualifying Course, had it not been for your cancellation or withdrawal, you:
 - (a.) would otherwise have met the Eligibility Criteria, your fee liability will be calculated in accordance with your Fee Schedule with the International Early Bird Discount applied; or
 - (b.) would not otherwise have met the Eligibility Criteria your fee liability will be calculated on the basis of the full Annual Tuition Fee for your Qualifying Course as set out in the Fee Schedule but without the International Early Bird Discount applied.

10. What happens if you receive the International Early Bird Discount but decide to defer or intermit while on the Qualifying Course?

- 10.1. Your right to defer or intermit your place on a Qualifying Course and your associated liability for any Annual Tuition Fees is set out in our Student Terms and Conditions and Fee Schedule.
- 10.2. If ULaw allows you to defer or intermit your place on a Qualifying Course in accordance with our Student Terms and Conditions, provided that you commence or recommence your Qualifying Course no later than 12 months after the original start date of your Qualifying Course, you will still be entitled to the International Early Bird Discount if you continue to meet the Eligibility Criteria.
- 10.3. Please be aware that Annual Tuition Fees payable for the Qualifying Course may increase between the date on which you defer or intermit and the date on which you start or re-join your Qualifying Course. You will be expected to pay the increase in the Annual Tuition Fees.

11. What happens if you are allocated an International Early Bird Discount but decide to transfer to a different course?

11.1. Please refer to our Student Terms and Conditions for the terms that apply to any requests to transfer to an alternative course. If you wish to transfer to another course offered by ULaw, you will only be eligible to receive the International Early Bird Discount if you are transferring to another Qualifying Course and you otherwise continue to meet the Eligibility Criteria.

12. General

12.1. The International Early Bird Discount is made available to students at the sole discretion of ULaw and ULaw's decision shall be final.

12.2. You understand and acknowledge that places on the Qualifying Courses are subject to availability.

12.3. These Terms apply in addition to (and do not replace) our Student Terms and Conditions in relation to your Qualifying Course. Please refer to our Student Terms and Conditions for other terms that apply to your Qualifying Course. If there are any conflicts or discrepancies between these Terms and our Student Terms and Conditions, the Student Terms and Conditions will prevail.

12.4. These Terms (including any non-contractual obligations arising out of or in connection with these terms) are governed by English law and are subject to the jurisdiction of the English courts.

12.5. ULaw may be responsible to you for foreseeable loss and damage caused by ULaw. If we fail to comply with these Terms, we are responsible for loss or damage you suffer that is a foreseeable result of our breaking these Terms or our failing to use reasonable care and skill, but we are not responsible for any loss or damage that is not foreseeable. Loss or damage is foreseeable if either it is obvious that it will happen or if, at the time the contract was made, both we and you knew it might happen, for example, if you discussed it with us during the application process.

12.6. We do not exclude or limit in any way our liability to you where it would be unlawful to do so. This includes liability for death or personal injury caused by our negligence or the negligence of our employees, agents or subcontractors; for fraud or fraudulent misrepresentation.

12.7. ULaw reserves the right, with reasonable cause, to withdraw your place on or exclude you from a Qualifying Course or withhold the International Early Bird Discount if you violate any of these Terms and/or any other applicable ULaw policies or terms and conditions including (but not limited to), the Student Terms and Conditions. 12.8. ULaw may make minor amendments to these Terms at any time. Any amendments will be published on ULaw's website and notification given to you of any such changes that affect you.

12.9. Even if ULaw delays in enforcing these Terms, ULaw can still enforce them later. If ULaw does not insist immediately that you do anything you are required to do under these Terms, or if ULaw delays in taking steps against you if you break these Terms, it will not mean that you do not have to do those things or prevent ULaw from taking steps against you at a later date.
